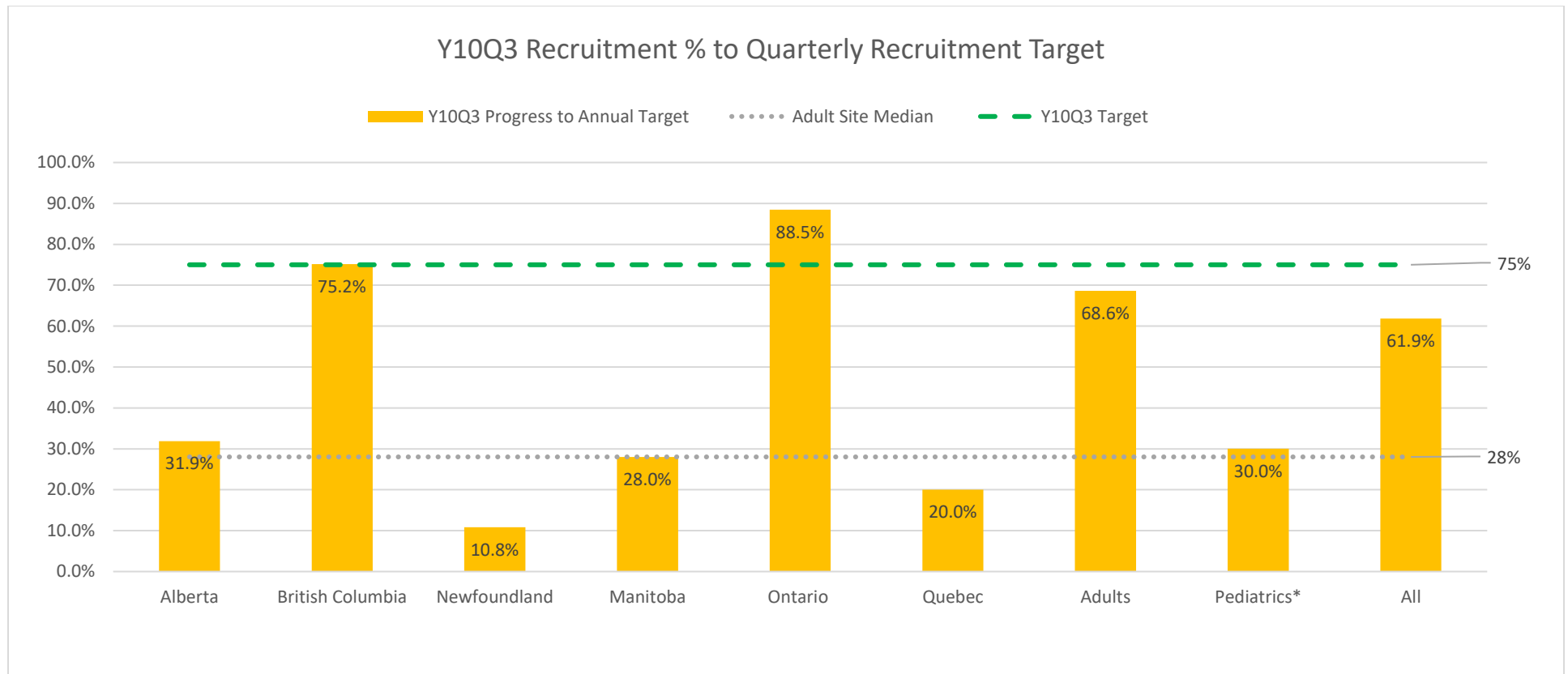

Section A: Patient Access and Recruitment to the 3CTN Portfolio Trials

Patient Recruitment at All Network Sites

Objective: To improve patient access to academic clinical trials and improve patient recruitment by greater than 100% within five years.



Notes:

- 852 patients were recruited (827 to Adult and 25 to Pediatric cancer centres) to Portfolio trials in Quarter 3 bring the Y10 Network total to 2779.
- Overall, ~24% of Adult Sites (9 out of 38) are on track to reach their Y10 target 85% above pre-3CTN baseline.
- *Pediatric progress to pre-3CTN baseline recruitment is shown.

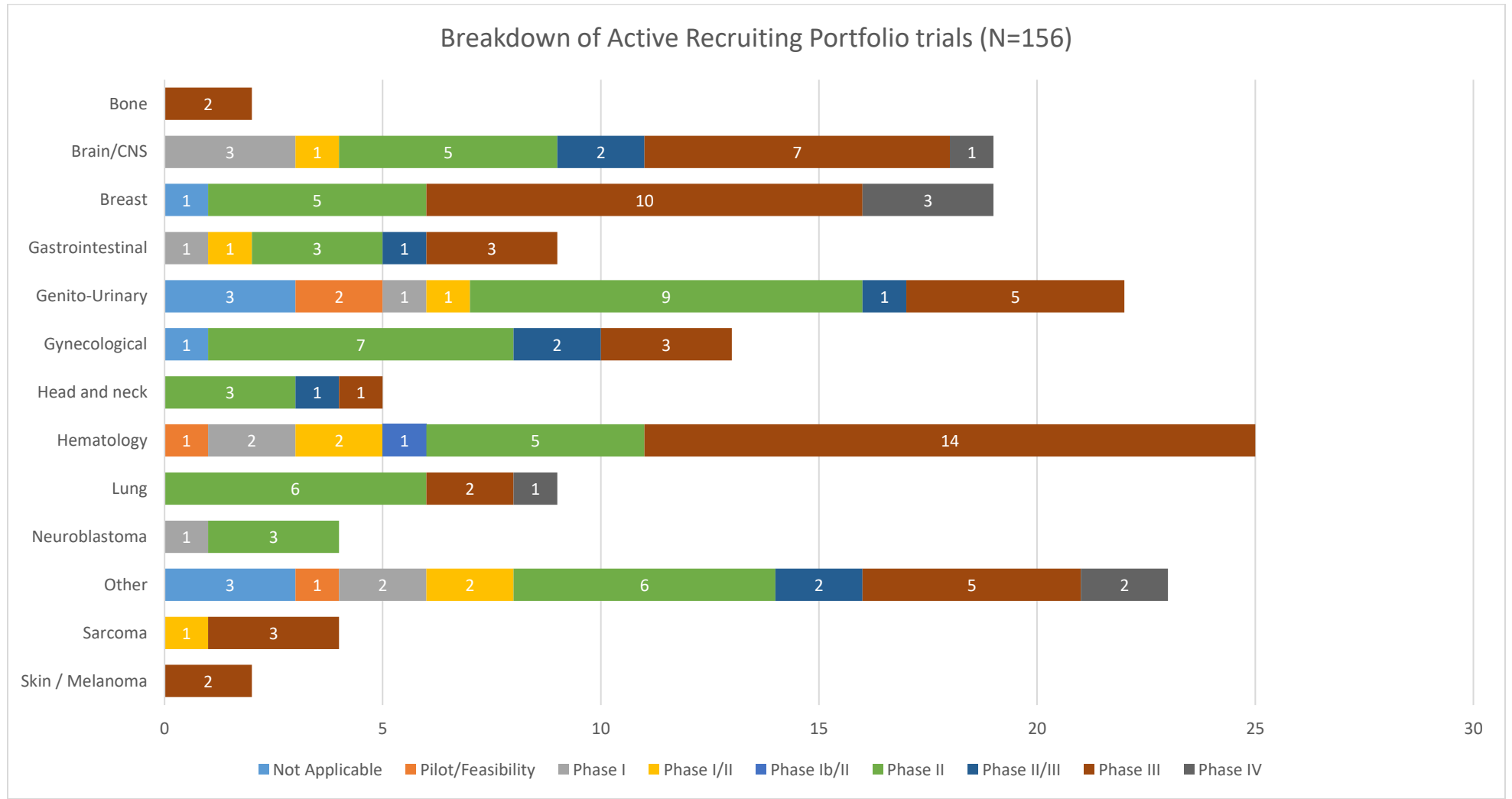
